5.6 Parish Field Car Park Re-Surfacing

No updates had been received. Cllr Gooch will contact Maidstone Borough Council to seek advice. Cllr Manser asked whether BPC would consider leaving the re-surfacing for three years, Cllr Vizzard suggested that any quotes which are received should be considered and to wait to hear any advice that is offered. A final decision can then be made on all of the information.

5.7 Tree branch removal: Request from resident

BPC agreed that if the branch is overhanging in to the garden, then they are entitled to remove it. The Clerk will write to the resident to inform them that members are happy for the offending branch to be cut back.

6. PLANNING

6.1 Applications received prior to the meeting

18/500354/FULL – Scraces, Rectory Lane, Barming – No objections to the amendment.

18/501677/FULL - Land to the rear of 10-16 North Street, Barming – Members were aware of concerns about a previous application some years ago to develop garden land rear of Bull Orchard. They felt that there is no need for additional development within the area as Maidstone Borough Council has met its housing needs and are concerned that the property could be extended to a two storey dwelling in the future. If the planning department are minded to approve this application, BPC would like the following conditions imposed:

- The application is to have permitted development rights removed.
- The application is to be confined to a single storey development as a second storey would overlook the neighbouring properties.

If the conditions are not put in place BPC would like this application taken to committee.

Cllr Vizzard as a member of MBC Planning Committee and Cllr Doe as an affected resident are excluded from commenting on this application.
